Dearly Beloved of God,

Resumption of Church Services at TOD.

Grace and peace of God be with you continually in Jesus name.

In the past 6 months of this year (April to October), we had stopped church service in our building in order to help public health efforts to control the spread of Covid 19. Gladly to the Glory of God, none of our members has died of Covid 19 despite the multiple fatalities across the world. Ps 91: 1-11 is true and our God is faithful and is our refuge.

Government has carried out a phased re-opening of the economy in the last months. We now also plan to return to worshipping in the church building on the 1st of November, 2020 but with restrictions. We encourage all our attending members and any new members to comply accordingly.

1. Follow all government public health advice during commuting in public transport to and from church - which includes the use of nonmedical face masks, social distancing, washing of hands, public etiquette, use of sanitizers as applicable, etc.
2. If you are sick or show Covid-like symptoms, stay at home with your family. Inform us (for support in kind, ministerial care and prayers) and report to the health authorities. Online Streaming of all our services will continue for those not able to make it to church and for our international congregation.
3. Upon arrival in Church, you are to follow the rules and restriction we have put in place in the building to uphold your health and safety. We have made modifications both in the building and in the way we worship to help compliance.
4. You will be required to use the sanitizer provided at the entry points and at designated points within the building. Also to keep all surfaces clean and avoid littering and contamination.
5. You are to follow the directions for entry/exit, to walk and to sit only in designated areas (clearly marked for the 1.5m distancing). Provision has been made for families to sit together
6. You will be required to wear nonmedical face masks while in church. The Church reserve the right to carryout temperature screening at entry points if she deems it fit to do so.
7. We also reserve the right to ask anyone who does not conduct himself properly to leave the building as we are very intentional at TOD in upholding health and safety standards for the benefit of all. This will be enforced. We will continue to strive to provide clean and safe environment for people to worship freely.
